## Plan Options

### DAILY PLAN

### MULTI-TRIP ANNUAL PLAN

- ▶ • Ideal if you travel for pleasure and/or for business multiple times during a calendar year
- Four plan options: Max. 30, 45, 60 or 90 consecutive days of travel.
- Optional: COVID-19 for people age 71 and older.

### EXTENDED STAY PLAN

- ▶ • Ideal for international students, executives assigned to work overseas or individuals with long-term pleasure trips
- Minimum two months (60 days) - Maximum one calendar year (365 consecutive days of travel.)

### FAMILY PLAN

- ▶ • Designed for families consisting of 2 adults (spouses or not) over 21 years old and up to 3 children under 21 years of age
- Minimum 5 days - Maximum 90 consecutive days of travel
- Three people minimum purchase for this plan.

### STUDENT PLAN

- ▶ • Designed for international students up to 45 years old
- Minimum 4 months - Maximum 12 consecutive months of travel.

### CORPORATE PLAN

- ▶ • Ideal for companies with a large number of travelers
- The plan is pre-purchased from 250 or more days of assistance
- The plan has a validity of 365 days from its purchase
- Provides access to a self-management platform for better control and distribution of each traveler.
